Subsequently, the final answer key and result will be published, which will be binding on all the candidates and no further claim / clarification would be entertained thereafter.

### **Guidelines for Candidates seeking any clarifications with regard to Provisional Answer Keys**

- a) Apply online (**recruitpuda@gmail.com**) to the Punjab Urban Planning and Development Authority, Mohali clearly indicating the grievance and relevant objection(s)/counter-objections along with all necessary enclosures in the prescribed format (**Ref : Annexure-I for format**) which can be downloaded from the Punjab Urban Planning and Development Authority, Mohali website([www.puda.gov.in](http://www.puda.gov.in)).
- b) Clarification/objections/counter-objections regarding provisional answer keys should reach the office of Chief Administrator, Punjab Urban Planning and Development Authority, Mohali by **online mode and a hard copy** along with a crossed Demand Draft of **Rs. 649/- (Rupees six hundred forty nine only) per clarification**, drawn in favour of the “Punjab Urban Planning and Development Authority, Mohali” payable at Mohali.
- c) The demand draft along with prescribed copy of the grievance form should be sent by speed post to The Chief Administrator, Punjab Urban Planning and Development Authority, PUDA Bhawan, Sector 62, Mohali-160 062.
- d) Only in case the clarification/objections/counter-objections sought is upheld, the money would be refunded in total after the recruitment process is completed.
- e) No request for clarification of provisional answer keys beyond the last date as stipulated on the Punjab Urban Planning and Development Authority, Mohali website will be entertained.

**Note:** Seeking clarification/objections/counter-objections as above is only for provisional answer keys. Such clarifications will not be entertained after the publication of Final answer keys.

Any verifications / clarifications sought by the candidate will be put forth to the duly constituted expert committee of the Examination Conducting Authority for their consideration. The decision of the expert committee shall be binding to all the stakeholders and no further clarification shall be entertained at any level.
