Regarding drawing the pay of the appointed candidate, as per Notification No. 7/204/2012-4FP1/66, Dated 15/01/2015 Govt. of Punjab Department of Finance (Finance Personnel-I Branch) Chandigarh and Notification No. 1/62016-4P.P.1/834680/1 dated 07/09/2016 Govt. of Punjab Department of Personnel (Personnel Policies-1 Branch), Chandigarh fixed emolument equal to Minimum of the Pay Band without any Grade Pay or any allowance will be paid during the probation period of three years. It is also clear that Annual increment

or any other allowance except travelling allowance will not be paid during the probation period of three years.
